**RESTAURANTS AGAINST HUNGER CAMPAIGN MEMORANDUM OF AGREEMENT**

1. ACTION AGAINST HUNGER also known as FUNDACION ACCION CONTRA EL HAMBRE and ACF INTERNATIONAL, is an international, non-stock, non-governmental and non-profit charitable relief and development organization licensed to transact business in the Philippines whose objective is to fight against hunger in the world by organizing emergency missions in nutrition, health and hydrology, as well as by training professionals capable of working in emergency humanitarian tasks in affected areas in accordance with the terms established in the by-laws of the Foundation.
2. The restaurant establishment, whose data appear on the REGISTRATION FORM, agrees to collaborate with Action Against Hunger through the campaign called Restaurants Against Hunger ©. This campaign is an endeavor to raise awareness of the problem of child malnutrition in the Philippines and to raise funds through the cooperation of participating restaurants and their clients.
3. The specified data of the participating company that appears on the REGISTRATION FORM are accurate and corresponds to a restaurant establishment, which henceforth, will be called THE RESTAURANT.
4. By signing this agreement, THE RESTAURANT agrees to launch the campaign, "Restaurants Against Hunger" ©, a campaign which belongs to Action Against Hunger Foundation, in accordance with this agreement and on the information provided by any of the COMMERCIAL DATA given.
5. The data which refer to THE RESTAURANT as indicated in the materials published for the campaign promotion, communications, media appearances and other promotional activities, are those that are collectively referred to as "COMMERCIAL DATA".
6. To impart knowledge of the campaign to the restaurant personnel and customers, promotional materials will be sent to THE RESTAURANT prior to the start of the campaign. 9. THE RESTAURANT pledges to raise donations corresponding to the amount of charity dishes ordered by its customers; as well as the income at the end of the campaign as indicated in paragraph 8.
10. Personal data provided under this agreement is protected from unauthorized disclosure, distribution, and processing under the provisions of Republic Act No. 10173 and its Implementing Rules and



Regulations. Any violation of protected rights shall subject the offending party to civil and criminal sanctions, including damages and compensation as may adjudged to be due the injured party.

11. Failure to comply with the obligations stated in this document will result to its full legal resolution. The injured party is entitled to claim for damages and compensation in accordance with the law.
